**Reminder - 10% SECP Fee on Transactions**

---

With reference to circular **PMEX/MKT,BD&CS/2014/09** dated February 24, 2014; all members are reminded that with effect from Monday, March 03, 2014, the SECP Transaction Fee, calculated at 10% of Trading Fee of the Exchange, will be collected along with Exchange's trading fee on all transactions undertaken on PMEX platform. This fee would be applicable on both sides of trades in all contracts.

Brokers using the E-Books back office software are requested to complete their EOD process by 12:00pm on Monday, March 03, 2014. After 12:00pm the Exchange will revise the trading fee of all commodity futures contracts in line with this circular.
