## **New Banking System Offered by MCB**

As part of our continuous endeavors to improve the quality of services provided to our clients, PMEX is pleased to inform you about the new MCB banking system called "Online Funds Transfer (OFT)".

The salient features of OFT are:

- No transaction cost charged by MCB
- 24/7x365 funds transfer facility
- Mapping of broker account with PMEX: This means through OFT funds will not be transferred to any account other than Client Group account being maintained with PMEX. Transfer to any account other than the one maintained with PMEX can be done through normal banking instruments
- No restriction on the value or number of transactions

The OFT registration form is attached with this circular. For further action please follow the below procedure to register for OFT:

- Mention PMEX Initial Margin Account Number in PMEX Collection Account Number field
- Mention your MCB Client Group account in PMEX broker account field
- Fill in the user details i.e. name of the person who will operate the account
- The authorized signatory of your MCB Client Group account will sign the form
- Get the signature verified from your MCB branch
- Send the form to Market Operations Department of PMEX

We request you complete the registration latest by January 08, 2014. On completion of registration, MCB will send you a Login ID and Password through email to the address specified in the registration form.
