Subject: Updating of Gazette of Pakistan S.R.O.s Pertaining to individual/entities in Taliban and (Da'esh/Al Qaida) Sanctions Committee Consolidated list

Please find enclosed 02 copies each of the updated Gazette of Pakistan Statutory Regulatory Orders Notifications (S.R.O.s) No. 752 (I)/2017 dated 03 August 2017 for appropriate action at your end.

- In pursuance of the UN Security Council Resolution No. 1267(1999) and its subsequent resolutions 1988 and 1989, SROs are issued by the Government of Pakistan whenever the Consolidated List maintained by the 1267 Sanctions Committee is updated, to provide legal cover for implementing Sanction Measures under the UN Security Council Resolutions. These sanctions are overseen by the ISIL (Daesh)/Al-Qaida and Taliban Sanctions Committees which have been established pursuant to paragraph 6 of resolution 1267 (1999). The targeted individuals and entities are placed on the Consolidated List.
- UNSC Resolutions 1267 (1999), 1333 (2000), 1373 (2001), 1390 (2002), as reiterated in resolutions 1455 (2003), 1526 (2004), 1617 (2005), 1735 (2006), 1822 (2008), 1904(2009), 1988 (2011), 1989 (2011), 2082 (2012), 2083 (2012), 2160 (2014), 2161 (2014) and 2170 (2014), 2178 (2014), 2199 (2015), 2253 (2015), 2255 (2015) and 2368, has obliged the Member States to perform following actions as as and when the Consolidated list is updated.
  - a) to freeze without delay the funds and other financial assets or economic resources, including funds derived from property owned or controlled directly or indirectly:
  - b) to prevent the entry into or the transit through their territories;
  - c) to prevent the direct or indirect supply, sale, or transfer of arms and related material, including military and paramilitary equipment, technical advice, assistance or training related to military activities, with regard to the individuals, groups, undertakings and entities placed on the Consolidated List.

AND WHEREAS through paragraph 1 of United Nations Security Council resolution 2253(2015) adopted on 17 December 2015 under Chapter VII of the United Nations Charter, the United Nations Security Council has decided that, from the date of adoption of this resolution, the 1267/1989 Al-Qaida Sanctions Committee shall henceforth be known as the "1267/1989/2253 ISIL (Da'esh) and Al-Qaida Sanctions Committee" and the Al-Qaida Sanctions List shall henceforth be known as the ISIL (Da'esh) and Al-Qaida Sanctions List;

Al-Oaida, and associated individuals, groups, undertakings, and entities, recalls also that this obligation applies to the direct and indirect trade in oil and refined oil products, modular refineries, and related material including chemicals and lubricants, and other natural resources, and comply with their obligation to ensure that their nationals and persons within their territory do not make donations to individuals and entities designated by the Committee or those acting on behalf of or at the direction of designated individuals or entities;
